With this request, please exercise your discretion and reconsider your original denials and release in full or in part the two withheld documents. In November 2014 the two documents were shown to a Swedish government official and the resulting media reports described the documents as being "trivial and without meaning" (Exhibit 2). The two documents are also described in paragraphs 81 and 82 in U.N. Report A/70/132 (Exhibit 3).
